### **Use of Student Work and Personal Information Parent/Guardian Permission Form**

*The Local Authority Freedom of Information and Protection of Privacy Act (LAFOIPP)* require that schools obtain informed consent for the collection and use of personal information that is not authorized under the *The Education Act, 1995*.

**Christ the Teacher Catholic Schools may wish to use the personal information that it collects about a student for the following purposes:**

#### **1. Education purposes in the school community**

- Students name, grade level and age, individual photographic or video image, team photo, candid or special event photos for the purposes of:
  - school calendar, newsletter, or other school publications
  - honour roll, yearbook, graduation, academic activities and achievement, school related athletic activities and achievements
- Student work, such as: art work; writing samples; audio, video photographic presentations; individual commentaries or interviews for the purposes of
  - educational or promotional use
  - display student work in the school, division office, and churches
  - display student work at sponsored events

#### **2. Public media including the Internet**

Sharing information with newspapers, radio and television and other media including the school or school division website may include:

- Images of
  - Individual student with or without student's first and last name
  - Teams or other school groups
  - School events and activities
- Announcement of names, grade level and age
  - Winners of awards, contests, competitions
  - Congratulatory messages for graduation, academic or athletic achievement
- Student commentary
  - Media interviews with students upon request to the school/school division

#### **3. Class Lists**

Sharing home contact information to classmates, a home room parent group or the School Community to assist with organization of school events or in the event of an emergency situation.

Note: Student lists may be distributed electronically and/or in paper copy to a limited circulation list as noted.

In sharing any information the school and school division will respect privacy legislation and parental permissions and will balance the risks of sharing information with the public with the interests of students in sharing the pride of their achievements.

**NOTE:\*\*** Images posted on the web are publicly accessible. The School Division is responsible for the content of the school division website, but is not responsible for what other users may do with images or content posted on the site.

**\*\*Special situations may arise during the school year where a separate form may be utilized for parental consent.**

## **Re: Student Use of Electronic Information System**

Dear Parents:

The Christ the Teacher Catholic School Division has established a division-wide Electronic Information System to facilitate the educational process and administrative services. This system also allows access to the Internet. The Internet is a global network that contains databases, reference materials, and resources. This global resource can extend students' educational experiences far beyond those currently available through other means.

Along with the use of this resource come certain responsibilities. Although the division provided training in the use of the division's telecommunications network that emphasized the ethical use of the resource, it is possible that your child may access some material you may find objectionable. While the division will take reasonable steps to preclude access to such material through electronic filtering and classroom management, it is not possible for the division to guarantee that it can completely prevent such access.

Please take a few minutes to speak with your child regarding the *Acceptable Use for Electronic Information Systems* administrative procedure. Although division teachers and administrators will continue to emphasize proper behavior, your help in emphasizing the importance of the guidelines will go a long way toward ensuring compliance. I ask that you read the administrative procedure and sign the permission form to indicate your preferences for your child's interaction with the Division Electronic Information System.
